Restraint Reporting

- The reporting of incidents of restraint for <u>all students</u>, both with and without disabilities, is captured solely through the Involuntary Examination, Restraint and Seclusion (IERS) web application.
- Section (s.) 1003.573(7), Florida Statutes (F.S.), Seclusion and restraint of students with disabilities in public schools, requires each school to prepare an incident report within 24 hours after a student is released from restraint.
- The Florida Department of Education (FDOE) is responsible for establishing standards for documenting, reporting, and monitoring incident reports related to the use of restraint.
- Each school district must develop policies and procedures that govern the reporting of restraint incidents.
- Any revisions made to a school district's policies and procedures must be filed with the Bureau of Exceptional Education and Student Services (BEESS) within 90 days.

Seclusion Reporting

- Section 1003.573(2), F.S., states that "each school district shall prohibit school personnel from using seclusion."
- The U.S. Department of Education, Office for Civil Rights, requires that any incidents of seclusion of both students with and without disabilities be reported for the Civil Rights Data Collection (CRDC).
- The reporting of incidents of seclusion for all students, both with and without disabilities, is captured solely through the Involuntary Examination, Restraint and Seclusion (IERS) web application.

Involuntary Examination Reporting

- All public schools, including charter schools, are to make a reasonable attempt to notify the parent of a minor student before that student is removed from school, school transportation or a school-sponsored activity for an involuntary mental health examination.
- The principal or the principal's designee must use all available methods to contact the student's parent, guardian or known emergency contact, including phone calls, text messages, email, voicemail and other available methods of communication provided by the parent and document the number of attempts made to contact the student's parent, guardian or other known emergency contact and the outcome of each attempt.
- Each district school board shall adopt a policy to require the district superintendent to annually report to FDOE the number of involuntary examinations, as defined in s. 394.55, F. S. which are initiated at a school, on school transportation or at a school-sponsored activity and the number of children for whom an examination was initiated.

Restraint Reporting Timelines

- Pursuant to s. 1003.573(7), F.S., a school shall prepare an incident report within 24 hours after a student is released from restraint. If the student's release occurs on a day before the school closes for the weekend, a holiday, or another reason, the incident report must be completed by the end of the school day on the day the school reopens.
- A school shall notify the parent or guardian of a student each time manual or physical restraint is used. Such notification must be in writing and provided before the end of the school day on which the restraint occurs.
- A school shall also provide the parent or guardian with the completed incident report in writing by mail within 3 days after a student was restrained.

Involuntary Examination Reporting Timelines

- It is recommended that an Involuntary Examination incident is entered into the IERS portal within 48 hours. This ensures the accuracy of the information and timely follow-up for the student who has experienced a crisis event.
- If the incident is not finalized within 30 days the record will be locked and the incident will need to be reentered into the IERS portal.

IERS Application Business Rules

- School-level users can delete or edit Final Draft restraint reports within 30 days.
- District-level users can delete RESTRAINT reports created in the past 30 days.
- District-level users can see what RESTRAINT and INVOLUNTARY EXAMINATIONS have been deleted.
- Only ADMIN level users can unlock or delete INVOLUNTARY EXAMINATIONS.

Getting Started: Login

1) Login at https://portal.fldoesso.org/PORTAL/Sign-On/SSO-Home.aspx.



- 2) Enter the DOE-assigned User ID and user-created password (if it's the user's first time logging in, please use the temporary password that was provided by the district).
- 3) Click the <u>Sign in</u> button.

4) The user will then be taken to the **Main Applications Menu.** Click on the text: <u>Involuntary Examinations and Restraint and</u> <u>Seclusion (IERS)</u>.

- After entering the Student FLEID or Student Local ID number, a pop-up window will appear titled "Confirm Student Information".

- The "Restraint Incident Report" screen will open. The incident report is all on one page, the user will have to scroll down to view the different sections of the incident report. For this user's manual, each section is broken down over the following pages.
- The first section is the student demographic information. This section includes the student's name, grade, date of birth, race, and gender. There is also a box to check if the student is identified as an English Language Learner (ELL). The student demographic information will prepopulate if manual entry was not selected on the previous screen. Please check for accuracy.
- If there is inaccurate information, resort to manual entry.

- The next section includes a drop-down menu for selecting the student's primary exceptionality.
- In addition to IDEA exceptionalities, there is an option to choose Section 504, Gifted, and N/A.
- The N/A option should be selected for restraint incidents involving students without disabilities.
- On the right side, are boxes the user can click if the student has multiple exceptionalities or qualifies under Section 504, with or without a 504 plan.

- The next section of the report pertains to the restraint incident itself. There is a drop-down menu with
 options to select the location where the restraint occurred. If the location is not listed, select "Other" or "Off
 Campus". Below the drop-down menu is a box to add a description for "other" or "off campus" if those
 options were selected.
- There is also a box for selecting the date and time the restraint started and stopped. This will appear in a drop-down format. After selecting the incident date, select the applicable time and indicate AM or PM.

- The section above involves the parental notification requirements of the restraint report. The first box is for the date the parent or guardian was notified. The date should be the first time the school-level user notified the parent or guardian of the restraint incident.
- The second box has options for selecting how the parent or guardian was notified. Select all options that were used.
- The final two boxes involve the date the incident report was prepared, and the date the final report was sent to the parent or guardian. The date entered for the prepared date should be the date the report was prepared in the IERS application. The date entered for the final report sent date should be the date the report was sent or given to the parent or guardian.

Note: the restraint report must be prepared within 24 hours after a student is released from restraint. The final

- The next sections involve more specific information regarding the restraint incident. First is a yes/no choice to indicate if the student is served in a residential setting.
- Next is a drop-down menu to select the crisis management training strategy used (CPI, PCM, TEACH, etc.). If "Emergency Situation" is selected, add a description of the emergency below the drop-down menu in the box provided.
- On the right-hand side, there is a box for selecting the date the student's crisis intervention plan (CIP) was last reviewed. Enter the date the Crisis Intervention Plan was last reviewed. Below that is a yes/no option if changes are recommended to be made to the CIP. If the team recommends changes, indicate "Yes" here.
- There is a yes/no option for identifying if the student has exceeded two (2) restraint incidents in a semester. If so, indicate "Yes" here. Per s. 1003.573(6), F.S., a crisis intervention plan (CIP) must be developed the second time a student is restrained in the same semester.

- The next box is the type of restraint used. The user will see a drop-down menu for choosing the most restrictive restraint used during the incident. If "Mechanical" is selected, describe the type of mechanical restraint used in the box provided below the drop-down menu. This box can be used for any restraint type to describe the specific type of restraint more clearly should the school-level user choose to do so.
- The next area involves a list of the people using or assisting in the restraint. Their first and last name, position, and date of their last Positive Behavior Intervention and Supports (PBIS) training should be entered. Per s. 1003.573(5), F. S., each district must identify who is authorized to use PBIS and provide training annually for them.
- The next section is to list any non-student witnesses to the restraint. First and last names, as well as their position, can be identified in the report. Do not provide student names.

Select one or more antecedents by checking the box or boxes that apply **and** further describe what happened prior to the restraint in the box provided. The user must select at least one antecedent.

Note: Section content must not be copied/pasted into each of the subsequent fields. Each field must have unique information when filling out IE/Restraint Report.

• Select one or more behavioral strategies used to prevent/de-escalate the behavior by checking the box or boxes that apply and further describe the context of the behavioral strategies used in the box provided. Be sure to select at least one behavioral strategy.

- The school-level user will then be asked to select the behavior that warranted the use of restraint from the dropdown menu. Select one of the behaviors the student was displaying that warranted the restraint **and** further describe the behavior in the box provided.
- At the bottom are boxes that need to be checked to identify who was at risk of immediate physical harm. More than one box can be checked, as applicable. Be sure to select at least one box.

Note: Restraint should only be utilized when all positive behavior interventions and supports are exhausted and there is an imminent risk of serious injury. Restraint may be used only to protect the safety of students and/or school personnel and must be discontinued as soon as the threat posed has dissipated.

- The first question above asks the school-level user to describe how it was determined that there was an imminent risk of serious injury or death to students or others. The reporter must detail what was likely to occur to students/staff if the restraint was not implemented.
- The second question includes boxes to select what occurred following the termination of the restraint. Select one or more events that occurred following the release of the restraint **and** further describe what transpired after the release of the restraint. Be sure to select at least one box.

- The final two sections on the restrain incident report pertain to injuries and care to students/staff following termination of the ٠ restraint. The upper section asks the school-level user about injuries, marks, or emergencies to the student. There is a yes/no choice followed by a write-in box to describe any injuries or care received.
- The lower section asks about injuries, marks, or emergencies to anyone else involved in the restraint incident. There is a ٠ yes/no choice followed by a write-in box to describe any injuries or care received.

At the end of the restraint incident reporting form, there is a button to click to save the report as a draft. The red arrow identifies where this button is on the screen. Select "Save Draft". • After clicking the "Save Draft" button, school-level users will be able to review the report in its entirety. The form will state "Data Saved Successfully" and have the word "DRAFT" located towards the top of the report in bright red. Proofread and ensure there are no errors. School-level users can make any edits needed within 30 days of the initial report.

- The user can then save in draft form again if they are not ready to submit the incident report by again clicking on the "Save Draft" button located at the bottom of the report. Once the report is completed and the user is ready to submit the incident report, they will need to click on the "Save Final" button. The red arrow shows where this button is located on the screen. Drafts should be finalized within 3 days to meet the notification requirements of s. 1003.573(7), F. S.
- School-level users are also able to delete the incident report within 30 days of the initial report if it was created in error or contains incorrect information that cannot be edited (such as the school in which the restraint incident occurred). To do so, users will click on "Delete this Record" located at the bottom of the screen.

- The section above involves the parental notification requirements of the Involuntary Examination report. The first box is for the date the parent or guardian was notified. The date should be the first time the school-level user notified the parent or guardian of the incident.
- There is a box below the date of notification to check if the 24-hour delay was used in this incident. Rationale for using the 24-hour delay includes situations where the delay was necessary to avoid jeopardizing the health and safety of the student, or when the delay is deemed to be in the student's best interest.

Per s. 39.201, F.S., if the rationale for the delay in notification was that it was in the best interest of the student, a report to the central abuse hotline must be made upon knowledge or suspicion of abuse, abandonment, or neglect.

• Below the parent notification area, there is a date box to identify the date a report was submitted to the central abuse hotline. On the right side of this section is a box to denote the time of the report by selecting the hour and minute the report was submitted. The user will then identify the time as AM or PM by selecting one of the two options.

- The section included above continues the parental notification requirements of the Involuntary Examination report. This section records each of the contact attempts to reach the parent or guardian. There are enough sections to document 5 attempts on the report.
- For each contact attempt, the user will first select the date and time of the contact attempt. Clicking in the date box will
 open a calendar to identify the date of the contact attempt. Next to the date box is a box to denote the time of the
 contact attempt by selecting the hour and minute. The user will then identify the time as AM or PM by selecting one of
 the two options.
- The user will then select the method of the contact attempt from the drop-down menu. Options for contacts methods include phone, text, email, mail and in person.
- The next box in the section allows users to identify who was contacted by selecting an option from the drop-down menu. Options for contact person includes parent, guardian and authorized emergency contact. The authorized emergency contact should be a known emergency contact that has authorization to receive notification of an Involuntary Examination.
- Finally, the user will select the outcome of the contact from the drop-down menu. Options for outcomes include no answer, left message, and successful. Users should continue to document contact attempts until the outcome is successful.

- Below the name box is a drop-down menu for selecting the role of the qualified professional who initiated the Involuntary Examination Process. One of the four options must be selected.
- At the end of the Involuntary Examination incident reporting form, there is a button to click to save the report as a draft. The red arrow identifies where this button is on the screen. Select "Save Draft". At a minimum, all items with an asterisk must be completed to save a draft.

The form will state "Data Saved Successfully" and have the word "DRAFT" located towards the top of the report in bright red. Proofread and ensure there are no errors. School-level users can make any edits needed within 30 days of the initial report.

- The user can then save in draft form again if they are not ready to submit the incident report by again clicking on the "Save Draft" button located at the bottom of the report. Once the report is completed and the user is ready to submit the incident report, they will need to click on the "Save Final" button. The red arrow shows where this button is located on the screen.
- School-level users are also able to delete the incident report within 30 days of the initial report if it was created in error
 or contains incorrect information that cannot be edited (such as the school in which the Involuntary Examination
 incident occurred). To do so, users will click on "Delete this Record" located at the bottom of the screen.

IERS Clarifications

- The reporting of restraint and seclusion for <u>all students</u>, both with and without disabilities, is captured solely through the IERS web application. For more information, please see the memorandum at <u>https://info.fldoe.org/docushare/dsweb/Get/Document-9697/dps-2022-167.pdf</u>.
- Section 1003.573, F.S., does not exclude any specific personnel from restraint reporting requirements.
- Restraints initiated by school resource officers, school safety officers, school guardians, or school security guards, as defined in s. 1006.12, F.S., must be reported in the IERS reporting system. This includes when on school property, school transportation, or at a school event.
- Reporting of a mechanical restraint initiated by a school resource officer (SRO) or other law enforcement officer (LEO) stops when the SRO or other LEO releases the student from the restraint *or* when the SRO or other LEO places the student under arrest.
- Reporting of mechanical restraint as part of transportation for an Involuntary Examination (IE) currently requires two separate reports to be made in IERS:
 - One incident report should be entered for the Involuntary Examination (IE)
 - One incident report should be entered for the mechanical restraint during transportation (if required)
 - <u>Note</u>: LEAs should collaborate with local law enforcement agencies to clarify policies and procedures regarding restraint during transportation for an Involuntary Examination and reflect those policies in the restraint incident report.
- Beginning with the 2023-2024 school year, the Student Information System (SIS) Discipline/Resultant Action Code data element will no longer include codes for L-Seclusion, M-Mechanical Restraint, or R-Physical Restraint. Per s. 1003.573(3)(c), F.S., physical restraint may be used only to protect the safety of students, school personnel, or others and may not be used for student discipline or to correct student non-compliance. - In the new Involuntary Examination, Restraint and Seclusion (IERS) auto-generated email notifications, incidents of IE and Restraint/Seclusion are separated, and the titles of the emails have been corrected to match.
- There are a total of 6 notifications related to restraint and seclusion incidents.
- There are a total of 4 notifications related to IE incidents.
- Many of the questions requiring a response from the restraint notifications have been removed from the email to reduce duplicating questions that were already answered in the restraint report.
- There is an addition to the notifications stating that a BEESS staff member may be in contact with the district following a review of the restraint incident report and they WILL be in contact following a seclusion incident.

Restraint Notifications

- Draft Status: This notification is triggered when a restraint incident is left in draft status for over 48 hours. The notification contains the date the incident report was saved as a draft and the name of the school in which the incident occurred. This notification serves as a reminder to the school-level user to return to the IERS application and finalize the draft. Per s. 1003.573(7), F.A.C., a school must provide the parent/guardian with the completed incident report in writing by mail within 3 school days after a student was restrained.
- 2. **Duration Over 60 Minutes**: This notification is triggered when a restraint incident that lasted longer than 60 minutes from start time to stop time is reported. The notification contains the date the incident report was saved as final and the name of the school in which the incident occurred. This notification serves as a prompt for a district-level user to review the incident and follow up with the staff involved. Additionally, this notifies districts that BEESS will also be reviewing the report and may be in contact should they have any questions or concerns about the incident.
- 3. **Multiple Incidents 30 Days**: This notification is triggered when multiple restraint incidents involving the same student within a 30-day period have been reported. The notification contains the dates of the restraints and the name of the school in which the incidents occurred. This notification serves as a prompt for a district-level user to review the incident, along with the student's records, and to follow up with the staff involved. The notification also asks districts to confirm that the requirements of s. 1003.573(6), F.A.C., involving crisis intervention plans (CIPs) were met. Additionally, this notifies districts that BEESS will also be reviewing the reports and may be in contact should they have any questions or concerns about the incidents and/or the student's CIP.
- 4. **Multiple Incidents 45 Days**: This notification is triggered when multiple restraint incidents involving the same student within a 45-day period have been reported. The notification contains the dates of the restraints and the name of the school in which the incidents occurred. This notification serves as a prompt for a district-level user to review the incident, along with the student's records, and follow up with the staff involved. The notification also asks districts to confirm that the

requirements of s. 1003.573(6), F.A.C., involving crisis intervention plans (CIPs) were met. Additionally, this notifies districts that BEESS will also be reviewing the reports and may be in contact should they have any questions or concerns about the incidents and/or the student's CIP.

- 5. **Mechanical Restraint**: This notification is triggered when a mechanical restraint incident is reported. The notification contains the date of the restraint and the name of the school in which the incident occurred. This notification serves as a prompt for a district-level user to review the incident report and confirm compliance with s. 1003.573(3)(a), F.A.C., involving the use of mechanical restraint. Additionally, this notifies districts that BEESS will also be reviewing the report and may be in contact should they have any questions or concerns about the incident.
- 6. Seclusion: This notification is triggered when a seclusion incident is reported. The notification contains the date of the seclusion and the name of the school in which the incident occurred. It also references the prohibition of seclusion per s. 1003.573(2), F.A.C. This notification serves as a prompt for a district-level user to review the incident report and follow up with the staff involved. Additionally, this notifies districts that BEESS will also be reviewing the report and WILL be in contact to discuss the incident as well as the next steps and any corrective actions needed.

Involuntary Examination Notifications

- 1. **Draft Status**: This notification is triggered when an IE incident report is left in draft status for over 48 hours. The notification contains the date the incident report was saved as a draft and the name of the school in which the incident occurred. This serves as a reminder to the school-level user to return to the IERS application and finalize the draft.
- 2. **Multiple Incidents 30 Days**: This notification is triggered when multiple IE incidents involving the same student within a 30-day period are reported. The notification contains the dates of the IEs and the name of the school in which the incidents occurred. This notification serves as a prompt for a district-level user to review the incident, along with the student's records, and follow up with the staff involved. The notification also asks districts to respond to several questions regarding referral for mental health services, development of a safety plan and parent involvement in the development of the safety plan.
- 3. **Multiple Incidents 45 Days**: This notification is triggered when multiple IE incidents involving the same student within a 45-day period are reported. The notification contains the dates of the IEs and the name of the school in which the incidents occurred. This notification serves as a prompt for a district-level user to review the incident, along with the student's records, and follow up with the staff involved. The notification also asks districts to respond to several questions regarding referral for mental health services, development of a safety plan and parent involvement in the development of the safety plan.
- 4. **Final Status**: This notification is triggered when an IE incident report is saved as final. The notification contains the date the incident report was saved as final and the name of the school in which the incident occurred. This notification serves as a prompt to both district-level staff and FDOE staff that an IE has occurred in the district.
